

# Tax-Free Childcare and Childcare Vouchers – SDE 11+ Course 2025-2026

SDE (Tuition) LLP is registered with Ofsted, eligible parents can save 20% or more on our Course fees by paying the Course fees using Childcare Vouchers or through the Government's Tax-Free Childcare scheme (together "Childcare Payments").

Childcare Vouchers and payments from your Tax-Free Childcare Account can only be accepted for in person 11+ Course classes held at one of our Ofsted-registered childcare settings (SDE Amersham, SDE Beaconsfield, SDE Gerrards Cross or SDE at Langley College). We cannot accept childcare payments for:

- Any class which is held online, including classes delivered through SDE's Hybrid Classroom facility at SDE Beaconsfield or any dedicated online lesson (this is because your child must be present at an SDE childcare settings for us to be able to provide a form of childcare); or
- Any class which takes place at a location other than those listed above, such as SDE's franchise locations in SW Herts or Earley (these locations are not Ofsted-registered Childcare Settings).

If you do not already receive Childcare Vouchers from your employer, you will no longer be able to enrol as the system has recently changed. However, you may still be eligible for the replacement scheme, which is called Tax-Free Childcare and is administered by the Government. #### **Payment Options**

#### > Pay SDE the full SDE Course fee in a single transaction

Many customers prefer to pay the full Course fee in one transaction. Once you have paid the Course fee in full, we will cancel your direct debit mandate and write to you to confirm that the Course fee has been received.

# > Pay SDE your usual direct debit instalment or variation thereof

For those customers who prefer to make Childcare Payments instead of, or in addition to, their scheduled Direct Debit instalments, please note the following:

### ■ <u>Direct Debit Mandate</u>

It is a condition of our service that you have in place with SDE an active Direct Debit Mandate until the Course fee has been paid in full. If you make a Childcare Payment to us, your forthcoming Direct Debit instalment or, where appropriate, instalments will be reduced or cancelled, depending on the amount of your Childcare Payment and the date your payment is received. We will write to you to confirm the new arrangements.

## Payment Deadline

In order to give us sufficient time to process your incoming Childcare Payment and to ensure your forthcoming Direct Debit instalment is adjusted or stopped in time, please ensure that your Childcare Payment reaches us by the Childcare Payment Deadline specified in the table below. Please note that each SDE Course has a different Direct Debit instalment schedule – please consult your confirmation email to ascertain the dates and amounts of the Direct Debit instalments for your child's SDE Course.

## **Notification of Payment**

Once you have made a Childcare Payment, please notify SDE by email to childcarepayments@sde11plus.com. This will help us track your payment. Make sure you send this email after you have made the transfer and not before. Please let us know:
